RULES & REGULATIONS

OF

"THE ARYAN CHARITABLE SOCIETY"

1. MEMBERSHIP:

The membership of the Society is open to any person or persons who has attained aged of majority and fulfils the terms and conditions of the society without discrimination of the religion, cast, colour or creed but subject to approval of the governing body if the membership is refused to a certain person or persons of refusal shall be communicated to the member concerned.

2. **SUBSCRIPTION**:

- (a) Admission Fee Rs. 100/- at the time of admission.
- (b) Subscriptions Rs. 100/- per annum.

3. TERMINATION OF THE MEMBERSHIP:

The Governing body shall have the power to expel any member from the society, on the following term & condition:-

- a) By no confidence motion passed by 2/3rd majority of votes in the general body meeting.
- b) Non-payment of subscription continuously for three months from the due date.
- c) On his/her written resignation.
- d) He/she has not attended three consecutive meetings of the general body without any intimation.

<u>NOTE</u>: The reason of termination of the membership shall be communicated to the member concerned.

4. APPEALS:

7. BANK ACCOUNTS:

8. **GENERAL BODY**:

9. **GENERAL BODY FUNCTIONS:**

- A) To consider any business brought forward by the Governing Body.
- B) There shall be an annual meeting of the General Body in the month of March.
- C) Not less than 15 days notice shall be given to the members from the date of general body meeting enclosing the agenda specifying the date, time and place and the quorum shall be 2/3rd.

10. SOURCE OF INCOME:

- A) Admission Fee
- B) Subscription
- C) Donation and special contributions.

The income of the society shall received from all sources will be utilized only for the promotion of its aims and objectives of the society any surplus income shall be utilized as per section 11 (5) of the income tax act 1961.

- E. The Governing body shall start the meeting atleast once in a month.
- F. To accept donation charities, loans, grants, properties, etc. from public other association agencies Govt. department interest of the promotion of the aims and objects the Society.
- G. The member of the managing committee including the Chairman and the manager of the school shall be nominated by the Governing Body.

14. MANAGEMENT OF FUNDS:
